

4. **Aims and Objects of this Trust** :  
Without any difference of caste – creed and color would be as under for the following objects and aims.

1. This trust will undertake all activities and work for the interest and benefit of the people, for economic and social development for wide spread of Education.

2. To establish conduct and impart education from Pre – Primary to Higher Education to run Balvadi, Bal Mandir, Secondary School Higher Secondary Schools and to maintain them.
3. To undergo all activities for the spread of Education such as to conduct and maintain Primary, Secondary & Higher Secondary Schools & Hostels, Hospitals, Organizations, (In Rural Backward Area of Gujarat).
4. To do constructive network with small, middle and large size NGOs, Trusts, groups, youth clubs, women Organizations, societies, Educational institutions, and promote and strengthen their aims and objectives for the betterment of the society and to promote the aim and objective of the lead India foundation through them.
5. To promote international, National and regional cultural exchange programs, Traditional knowledge, access to information, human rights and justice, Intentional and National fund raising program for the networking NGOs through the active Participation of Networked NGOs.
6. Organize educational and vocational training program with special concern for deprived sections, women / girls and unemployed youth to provide new skills, refine / sharpen / upgrade the existing skills leading to employment, self employment and income generation.
7. To spread awareness about for protection of environments to control Global warming and climate change population.



8. To promote / solve cause of health care, food problem, cause of health care, food problem, housing / shelter problems and humanitarian relief / refugees / indigenous people problems.
